### Rural Residency Planning and Development (RRPD) Program

The FORHP-supported Rural Residency Planning and Development Program (RRPD) provides start-up funding for new residency programs to address physician workforce shortages in family medicine, internal medicine, psychiatry, general surgery, preventive medicine, or obstetrics and gynecology. Eligible applicants are rural hospitals and graduate medical education consortiums that may include universities, Historically Black Colleges and Universities, and/or Tribal organizations.

A maximum of 15 awardees will receive up to \$750,000 for a three-year grant period to develop new and sustainable programs approved by the Accreditation Council for Graduate Medical Education, especially programs specifically designed for underserved areas and populations. The federal RRPD program helps organizations start new rural residencies that have plans to be sustainable over the long term through viable and stable funding mechanisms such as Medicare, Medicaid, and other public or private funding sources.

## Enhanced Auditing of Medical Examiner Noncompliance in 2024

In January 2024, FMCSA will be enhancing its comprehensive medical examiner (ME) performance monitoring and auditing program. Part of this program will include an increase in the Agency's monitoring of MEs for compliance with the Federal Motor Carrier Safety Regulations (FMCSRs).
